## Privacy Policy of HAHA VENDING

### 1. Introduction

This ***Privacy Policy of HAHA VENDING*** (hereinafter referred to as “this Policy”) applies when you access and use services of websites operated by Wuhan HAHA Bianli Science and Technology Co., Ltd. (with contact address at No. 8 Guannan Yuan 4th Road, Wanqili Science and Innovation Center (Mayinglong Industrial Park), Building B, Room 301, Donghu New Technology Development Zone, Wuhan, Hubei Province, China) and its affiliated companies (hereinafter referred to as “HAHA VENDING” or “We”) and/or use our services during our exhibition and/or market promotion activities, covering how we collect and process your personal data for the services in the EU and the United States.

We are fully aware of the importance of personal information to you. This Policy is drafted in accordance with the *General Data Protection Regulation* (“GDPR”), the *California Consumer Privacy Act* (“CCPA”) and other applicable laws and regulations. This Policy describes the purposes, methods, scope, and information security protection measures of HAHA VENDING’s collecting, using, storing, entrusted processing, sharing, transferring and public disclosure of your personal information, as well as the methods we provide to enable your control over your personal information, such as accessing, correcting and deleting your personal information under the scenarios listed in the first paragraph.

Please read carefully and fully understand this Policy to make choices that you deem appropriate. In addition, please also note the following:

**1. This Policy consists of two parts: (I) the General Terms; and (II) the Special Terms:**

a) **The terms in the "General Terms" apply to users in the EU**

and the United States.

- b) The "Special Terms", as part of this Policy, contain terms that apply only to specific jurisdictions where HAHA VENDING provides products and/or services. For the avoidance of doubt, the contents stated in the Special Terms apply only to users of HAHA VENDING within the specific jurisdictions.
- c) To the extent that there is any inconsistency between the General Terms and the Special Terms, the Special Terms shall prevail to the extent necessary to resolve such inconsistency.

2. This Policy applies only to the personal information we collect.

## **PART I GENERAL TERMS**

### **2. How Do We Collect and Use Your Personal Information**

To better serve your purposes, we may collect and use your personal information based on the principles of legality, fairness, necessity and transparency and based on purposes described in this Policy. If we use your personal information for purposes other than the scope described in this Policy, or collect your personal information for other special purposes, we will notify you in a reasonable manner and obtain your consent again before collecting or using such information.

#### **2.1 Personal Information Provided Directly by You**

To provide better service and enhance your using experience, we may need to collect the relevant information for the following functions. If you refuse to provide the following information, we cannot provide the following expanded business functions and services to you.

##### (1) Send Inquiry

If you wish to send inquiry, you need to fill in and submit your name, phone number, email or WhatsApp, country, purpose and message.

##### (2) Contact Us

If you wish to contact us, you need to fill in and submit your name, phone number, email, message, whether you have prior knowledge of vending, and whether you have a location.

##### (3) Get a Quote

If you wish to get a quote, you need to fill in and submit your name, phone number, email, message, whether you have prior knowledge of vending, and whether you have a location.

---

#### (4) Leave a Message

If you wish to leave a message for us, you need to fill in and submit your phone number, message, whether you have prior knowledge of vending, and whether you have a location.

#### (5) Learn More or Purchase Equipment

If you wish to learn more or purchase equipment, you need to fill in and submit your full name, email address, phone number or WhatsApp, and message.

#### (6) Participate in exhibition and/or other market promotion activities

If you wish to stay in touch with us during exhibition and/or market promotion activities, we may collect your name, phone number, email address, WhatsApp, company name, job title through an electronic form.

We may use (all or part of the) personal information you provide described in the scenarios (1) through (6) above to further communicate with you about our products and/or services, and for the purpose of profiling, targeted advertising and sending you marketing text messages or emails, and you can refuse to receive such messages or opt-out of targeted advertising and profiling by contacting us through the methods described in Section 10 of this Policy.

### **2.2 Exceptions Where Consent is not Required**

Please kindly note that under the following circumstances, the collection and use of your personal information does not require your consent:

- (1) Relating to the performance of our obligations under laws and regulations;
- (2) Directly related to national security and national defense security;
- (3) Directly related to public safety, public health or material public interest;
- (4) Directly related to criminal investigation, prosecution, trial and judgment execution, etc.;

- (5) To protect material legitimate rights and interests such as the life and property of data subjects or other individuals, but it is difficult to obtain consent from the individual;
  - (6) The personal information involved is disclosed to the public by the data subject itself;
  - (7) Collecting personal information that is lawfully and publicly disclosed, such as from lawful news reports, disclosed government information and other channels;
  - (8) It is necessary for the execution and performance of the contracts as requested by the personal information subject;
  - (9) It is necessary to maintain the safe and stable operation of the platform, such as finding and disposing of failure of products and/or services;
  - (10) Other circumstances stipulated by laws and regulations.

### **3. Collection and Use of Minors' Information**

**HAHA VENDING does not provide services to minors (the definition of minors shall be subject to the jurisdiction where you are located). If we accidentally collect personal information of minors (the definition of minors shall be subject to the jurisdiction where you are located), we will delete it immediately.**

### **4. How Do We Use Cookies and Similar Technologies**

HAHA VENDING may use Cookies and similar technologies to help you better use the services provided by this Platform. For details on our use of Cookies and similar technologies, please read the [\*Cookie Policy\*](#).

### **5. How Do We Entrust, Share, Transfer and Publicly Disclose Your Personal Information**

#### **5.1 Entrusted Processing**

In order to provide you with better services, certain functionality may be provided by our technical service partners and we may entrust these partners

---

to process some of your personal information. We will enter into strict confidentiality agreements with the companies, organizations and individuals to whom we entrust to process your personal information, in order to specify the responsibilities of both parties, the matters, period, nature and purpose of the processing and require them to process the personal information only in accordance with our instructions, this Policy and any other relevant confidentiality and security measures. If you refuse to allow our partners to collect the personal information necessary for the provision of the service, you may be unable to enjoy those services provided by such partner. Our partner includes:

- (1) Cloud service provider: We have entrusted a cloud service provider named hostinger to provide cloud storage services for HAHA VENDING.
- (2) Security and CDN service provider: We have engaged Cloudflare as our security and CDN service provider for website security protection and access acceleration services.

## **5.2 Share**

Respecting users' personal privacy is one of our basic principles. We will not share your personal information with any company, organization or individual except in the following circumstances: We may share your personal information in accordance with laws and regulations or mandatory requests from competent government authorities.

## **5.3 Transfer**

We will not transfer your personal information to any company, organization or individual, except for the following circumstances:

- (1) Transfer with express consent: we may transfer your personal information to other parties after obtaining your express consent;
- (2) Meeting the requirements of laws and regulations, legal procedures, or mandatory government requirements or judicial rulings;

- 
- (3) In the event of merger, acquisition or bankruptcy liquidation, in case of transfer of personal information is involved, we will require the new company or organization holding your personal information to continue to be bound by this Policy. Otherwise, we will require such company or organization to obtain your consent again.

Please be aware that if any transfer is required under the above circumstances, before the transfer, we will inform you of the purpose, type, transferee of the information to be transferred (if any sensitive information is involved, we will also inform you of the content thereof) and will conduct transfer after obtaining your consent, unless otherwise stipulated by laws and regulations.

#### **5.4 Public Disclosure**

We will only publicly disclose your personal information under the following circumstances:

- (1) After obtaining your express consent;
- (2) Disclosure based on laws: we may publicly disclose your personal information as compulsorily required by laws, legal proceedings, litigation or governmental authorities.

#### **5.5 Exceptions Where Prior Consent for Sharing, Transfer and Public Disclosure of Personal Information is not Required**

According to laws and regulations, under the following circumstances, we may share, transfer or publicly disclose personal information without obtaining your prior consent:

- (1) Relating to the performance of our obligations under laws and regulations;
- (2) Directly related to national security and national defense security;
- (3) Directly related to public safety, public health or material public interest;

- 
- (4) Directly related to criminal investigation, prosecution, trial and judgment execution, etc.;
  - (5) To protect material legitimate rights and interests such as the life and property of data subjects or other individuals, but it is difficult to obtain consent from the individual;
  - (6) The personal information involved is disclosed to the public by the data subject itself;
  - (7) Collecting personal information that is lawfully and publicly disclosed, such as from lawful news reports, disclosed government information and other channels;
  - (8) It is necessary for the execution and performance of the contracts as requested by the personal information subject;
  - (9) Necessary for maintaining the safe and stable operation of the product or service provided, including finding and disposing of failure of products or services;
  - (10) Other circumstances stipulated by laws and regulations.

## **6. How Do We Protect Your Personal Information**

We attach great importance to the security of your personal information. We have adopted multi-level protection measures such as technical safety measures conforming to industry standards and supporting organization structure and management system, to prevent your personal information from disclosure, destruction, misuse, unauthorized access, unauthorized disclosure or alteration to the greatest extent possible. In particular, the measures include the following:

### **6.1 Technical Measures for Data Security**

- (1) For the data transmission security, we adopt the cryptographic technology such as transport layer security protocol and deploy Https and other ways to prevent the transmission links from being eavesdropped, intercepted, and to establish a safe and private data environment and ensure the confidentiality and completeness of data.

---

(2) With regard to the security control of data access and use, we have implemented a strict data authorization control mechanism. The core production database is restricted to the internal network access and does not open public network ports. The production and testing environments are isolated by network segments. Manual execution of SQL is conducted through the auditing function built into the data management tool. The database operates in a primary-backup mode.

## **6.2 Organization and Management Measures for Data Security**

We have specifically established a network and data compliance leading group to lead the company's cybersecurity, personal information protection and data security works. In addition, we have established a series of systems concerning data security, and actively provided relevant special training sessions for our employees to raise their awareness of personal information protection and professional competence in this regard.

## **6.3 Security Incidents Handling**

(1) We will formulate emergency response plans for cybersecurity incidents, promptly handle security risks such as system vulnerabilities, computer viruses, cyber-attacks, and network intrusions. When an incident endangering cybersecurity occurs, we will immediately activate the emergency response plan, take corresponding remedial measures, and report to the relevant competent authorities in accordance with regulations.

(2) If a personal information security incident occurs, we will, pursuant to the requirements of the laws and regulations, inform you promptly of the basic information and possible impact of the incident, measures we have taken or will take to deal with the incident, suggestions for prevention and reduction of the risk on your own, and remedial measures for you, etc. We will inform you of the relevant information of the incident in a timely manner by email, letter, telephone, push notice and other means. Where it is difficult to inform data subjects one by one, we will publish an announcement in a reasonable and effective way.

---

(3) Meanwhile, we will also proactively report the responses to any personal information security incident as required by regulatory authorities.

Please be aware that, although we have implemented various security measures, the Internet is not an absolutely secure environment and email, IM and other methods of communication with our users are not encrypted. We strongly recommend that you do not send personal information by such means.

## **7. How Do We Store Your Personal Information**

The personal information we collect from you will be stored in the cloud servers deployed in the United States by our cloud service provider. For the daily operation, the staff of our headquarter in China will have access to the data stored in the cloud server. By agreeing to this Policy, you are deemed to allow us to process such cross-border transfer of personal information. We warrant that, unless otherwise stipulated by laws and regulations, we will store your personal information for the minimum period of time necessary to achieve the purposes for which you authorized. After the expiration of the storage period, we will promptly delete and/or anonymize your personal information. In the following circumstances, we may change the storage time of personal information to comply with legal requirements:

- (1) To comply with the application of relevant provisions such as laws and regulations;
- (2) To comply with the provisions of court judgments, rulings or other legal procedures;
- (3) To comply with the requirements of relevant government agencies or legally authorized organizations;
- (4) To protect the personal and property safety of us, our customers, users or employees;
- (5) Other uses reasonably necessary for legitimate rights and interests.

If HAHA VENDING was ceased due to business strategy or other

---

reasons, unless otherwise stipulated by laws and regulations, we will notify you such circumstance, stop collecting your personal information, and delete or anonymize collected personal information.

## **8. Your Rights**

We will try our best to ensure that you can access to your information. If we provide you with incorrect information, we will endeavor to provide any means to allow you to update or delete your information (unless we have to retain such information for reasons such as compliance with laws and regulations). You are entitled, in accordance with applicable laws and regulations, to:

### **8.1 Access to Your Personal Information**

Unless otherwise provided by applicable laws and regulations, you have the right to access your personal information at any time. For information about our collection of personal information, please refer to Section 2 and Section 12.2 of this Policy.

### **8.2 Correct Your Personal Information**

If you find that the personal information you have provided, or that has been processed by us, is incorrect, you have the right to correct the information by contacting us at any time in the manner described in Section 10 of this Policy, and we will respond to your request for correction as promptly as possible.

### **8.3 Delete Your Personal Information**

Unless otherwise provided by laws and regulations, you have the right to contact us to delete your information in the manner described in Section 10 of this Policy. You can request us to delete your personal information in the following circumstances:

- (1) Our processing of the personal information violates the laws or regulations;
- (2) We collect or use your personal information without your prior consent;

- 
- (3) Our processing of the personal information violates the agreement with you;
  - (4) You stop using our products or services;
  - (5) We no longer provide you with products or services;
  - (6) Other circumstances stipulated by the laws and regulations.

You hereby agree that once the deletion request is responded, your personal information will be deleted and any information you have provided and the record of actions you have taken will not be retrievable. The relevant information may not be deleted from our backup system immediately but will be deleted when the backup system is updated.

#### **8.4 Changing the Scope of Your Authorization and Consent or Withdrawing Your Authorization**

If you need to change the scope of your authorization for us to continue collecting your personal information, withdraw your other authorizations, or restrict or object to our processing of your personal data, you can contact us in the manner described in Section 10 of this Policy.

Where personal data are processed for direct marketing purposes, you have the right to object at any time to processing of personal data concerning you for such marketing, which includes profiling to the extent that it is related to such direct marketing.

You have right not to be bound by automatic decisions, including user profiling and targeted advertising, if such right is requested by the privacy laws in your jurisdiction.

Please understand that specific business functions and services require your information to be completed. After you withdraw your consent or authorization, we will not be able to continue to provide you with the services corresponding to the withdrawn consent or authorization and we will no longer process your corresponding personal information. However, your decision to withdraw consent or authorization will not affect the processing of personal information conducted before based on your previous consent or

---

authorization.

## **8.6 Your Other Rights**

Where permitted by law, you may make copies of your personal information, request to transfer your personal information to a designated personal information processor and request us to explain the rules for processing your personal information. You can exercise the above rights by contacting us through the contact information published in Section 10 of this Policy.

## **8.7 Respond to Your Afore-mentioned Request**

If you are unable to proceed through the afore-mentioned channels, please contact us through the contact information described in Section 10 of this Policy. For security purposes, we may ask you to provide relevant information to verify your identity before processing your request. We will respond as soon as possible. Unless otherwise required by the laws of the state that you are located, generally, we will reply to you within one month upon receipt of your request (If necessary, we may extend it by an additional 45 days as permitted by law. We will inform you the reason for the extension within the aforementioned 30-day period, such as the request is too complicated or too much in volume).

If you are not satisfied with the response you received, you can get in touch with us through the contact information described in Section 10 of this Policy and/or refer the complaint to the relevant regulatory authority in your jurisdiction.

In principle, we do not charge fees for your reasonable requests, but for repeated requests or requests that exceed a reasonable limit, we may charge a certain cost-based fee depending on the circumstances. We may deny requests that are unnecessarily repetitive, require excessive technical means (for example, a request to develop a new system or make a fundamental change in the existing practice), pose risks to legitimate rights and interests of others, or are highly impractical.

According to the requirements of the laws and regulations, we will not be

---

able to respond to your requests in the following circumstances:

- (1) Related to our performance of obligations stipulated by laws and regulations.
- (2) Directly related to national security or national defense security.
- (3) Directly related to public security, public health or material public interests.
- (4) Directly related to criminal investigation, prosecution, trial, execution of judgment, etc.
- (5) There is sufficient evidence to show that you have subjective malice or abuse your rights;
- (6) Where it is necessary to safeguard your or another individual's major legitimate rights and interests such as life and property, but it is difficult to obtain data subject's authorization and consent;
- (7) Responding to your request will cause serious damages to your legitimate rights and interests or those of any other individual or organization.
- (8) Where trade secrets are involved.
- (9) Other circumstances stipulated by laws and regulations.

## **9. How Do We Update This Policy**

**We may update or change this Policy from time to time, and such changes form part of this Policy. We will not impair any of your rights under this Policy without your express consent.** We also keep on file the previous version of this Policy for your reference. The previous privacy policy may be obtained by contacting us in the method described in Section 10 of this Policy.

**Please read the amended Policy carefully. If you don't agree to this Policy, or any amendment or update to this Policy, you may choose to stop using HAHA VENDING's product and/or service. However, please**

---

**be aware that this Policy will still govern your activities before you stop using the service.**

**We will publish any changes to this Policy on this page. In such cases, if you choose to continue to use our service, it means that you agree to be bound by the amended Policy.**

### **11. Additional Information for European Union Residents**

#### **11.1 HAHA VENDING's Lawful Basis for Processing Your Personal Information**

HAHA VENDING will process your personal information after obtaining your consent. The purpose of processing and the types of personal information need processing are specified in previous sections. If you have any question regarding our data processing activities, feel free to contact us according to contact information specified in Section 10.

Please note that HAHA VENDING may also have the right to process your personal information without your prior consent under the following circumstances in accordance with the GDPR:

---

(1) processing is necessary for the fulfillment of a contract when the data subject is one of the party(s) or when it is one of the preconditions for the data subject to enter into a contract;

(2) processing is necessary for being compliance with a legal obligation imposed on the controller;

(3) processing is necessary to protect the vital interests of the data subject or of another natural person;

(4) processing is necessary for the public interest or the exercise of official authority vested in the controller;

(5) processing is necessary for the purposes of the legitimate interests pursued by the controller or by a third party, except where such interests are overridden by the interests or fundamental rights and freedoms of the data subject which require protection of personal data, in particular where the data subject is a child.

## **11.2 Cross-border Transfer of Your Personal Information**

The personal information we collect from you will be transferred and stored in the cloud servers deployed in the US by our cloud service provider. For the daily operation, the staff of our headquarter in China will have access to the data stored in the cloud server. By agreeing to this Policy, you are deemed to allow us to process such cross-border transfer of personal information. To ensure that our headquarter process your personal information in a manner consistent with EU data protection laws, we will enter into the relevant agreements, which will contain provisions on the adequate protection of your personal information. At the same time, we have also taken corresponding compliance and protection measures for cross-border processing of your personal information in accordance with the requirements of applicable laws and regulations.

We have also deployed strict measures to safeguard your personal information, and if you have any questions regarding your personal information's security and/or our international transfer manners or would like to withdraw your consent to the international transfer, you may contact us

---

according to the contact information specified in Section 10 and Section 11.3 of this Policy.

### **11.3 Data Subject Rights**

We recognize and protect your lawful rights under GDPR, and you may exercise your rights at any time via methods stipulated in Section 8 of this Policy. Besides, you also have a right to lodge a complaint with a supervisory authority, even though we encourage you to first contact us with any questions or concerns.

Additional Rights in France: Residents of France have a right to send us specific instructions regarding the processing of your data after your death by contacting us according to contact information specified in Section 10 of this Policy.

## **12. Additional Information for California Residents**

### **12.1 Additional Rights for California Residents**

We recognize and protect your lawful rights under CCPA and other California Law. You may exercise your rights at any time via methods stipulated in Section 8. Besides, you also have the following rights:

(1) Right to Know Information Regarding Participation in Data Sharing for Financial Incentives

We will ask for your consent before collecting your personal information in connection with offering a financial incentive.

(2) Right to Opt Out of Sale of Personal Information to Third Parties

You have the right to opt out of any sale of your personal information by us to third parties. Please note that your right to opt out does not apply to our sharing of personal information with service providers, who are parties we engage to perform a function on our behalf and are contractually obligated and permitted to use personal information only within the scope and for the purposes specified in the contract.

(3) Right to be Free from Discrimination

You may always exercise all rights and we will not unlawfully discriminate against you for exercising your rights under the CCPA.

(4) California Shine the Light Law

Residents of the State of California have the right to request information regarding third parties to whom the company has disclosed certain categories of personal information during the preceding year for the third parties' direct marketing purposes. 2.
